- 2) Research students not included in search as most universities do not have "proper" homepages for candidates.
- 3) Search did not 'pick up' some of the names/ people included on/in the "AFSAAP African Experts clickable map (some "experts" are not academics)
- 4) Some academics (AFSAAP members) do not seem to have homepages (even a search with their names does not return a hit for a university homepage with details of their academic work).
- 5) Quality of the research included here: i.e when they use an African study only as an exemplar???
