

Dr. Mangeni's initial training in theatre was at Makerere's Music, Dance and Drama Department and later at University of Leeds where he earned a Master of Arts in theatre Studies, before earning a PhD in Applied Theatre from Griffith University, Australia.

His research and publications have been in the following areas: gender and theatre, community theatre or theatre for development address issues ranging from health, to human rights and development; education and drama, children's theatre play. He has written more than 5 community theatre plays. He has hosted a series of programs as well as written plays for both radio and television. He has directed more than seven theatrical productions in Uganda, Kenya, and Norway. # SPECIAL FORUM Putting Women At The Heart Of The African Renaissance

ECL1-4:30 - 5.30pm - Thursday Nov 28th

In African politics today, there are two female heads of state: Joyce Banda in Malawi, and Ellen Sirleaf - Johnson in Liberia. The country with the highest representation of women parliamentarians in the world is Rwanda. As the 'African Renaissance' gains steam, the Chair of the African Union Commission is a remarkable woman, Madame Nkosazana Dlamini - Zuma.

The African continent has demonstrated commitment to promoting gender equality and the empowerment of women. Almost all countries have ratified the Convention on the Elimination of All Forms of Discrimination against Women; more than half have ratified the African Union's Protocol on the Rights of Women in Africa. Other milestones include the African Union's declaration of 2010 - 2020 as the African Women's Decade.

But the scenario for African women is a complex one. Many women and girls continue to be marginalised with limited access to education health services, secure well paid jobs and protection from violence. This panel of prominent women will discuss the status of women in Africa and Australia and the role that women leaders can play in facilitating positive change in both countries.

# SPECIAL FORUM Kenya in 2013: a stable democracy in East Africa?

ECL 1 - 2 hours

Chair: Dr Samantha Balaton - Chrimes

Kenya has long been held up as a bastion of stability in East Africa. Compared to its neighbours Kenya's post - independence history is one of relatively stable, if sometimes quasi - dictatorial, government and largely steady if sometimes modest economic growth. Kenya is seen by global powers such as the US and European Union as a safe haven for investors and counter - terrorism cooperation, as well as safari - seeking tourists.

The discourse of Kenya's stability has been far more successful outside the country than within. Outsiders were shocked by episodes of instability such as the post - election violence of 2007 or the Westgate mall terror attack in September, but Kenyans were not. Kenya may never have experienced a (successful) coup or large - scale civil war, but its politics has not been as stable or democratic as outsiders would have us believe. A number of events in 2013 brought this to light.

#### Experts on Kenya convene to discuss these issues.

Prof. Sam Makinda is Professor of Politics and International Studies and the Chair of Security, Terrorism and Counter - Terrorism Studies at Murdoch University in Perth. He currently serves on the Australian Foreign Minister's National Consultative Committee for International Security Issues. He is also a member of the Council for Security Cooperation in the Asia - Pacific.

Thomas Mukoya is a photojournalist based in Kenya with Reuters News Agency. Thomas has over fifteen years of experience, including with The Nation Media Group. He has won numerous professional awards including KUJ Photojournalist of the year (2003), Photographers Giving Back award of Sweden (2010), and the Media Council of Kenya Photojournalist of the year (2013). He has also worked extensively in public information with humanitarian organizations as a photojournalist including UNHCR, UNICEF, Australia for UNHCR, MSF, ICRC, and the European Commission.

Christina Kenny is a PhD candidate at the Australian National University. Her PhD thesis, "We've agreed to be ruled": Women's public and private decision making in modern Kenya', focuses on the understandings and experiences of sex and sexuality rights, and civil and political rights among women in Kenya. Christina has returned from nine months in Kenya conducting field work, working with the Kenya Human Rights Commission's Election Monitoring Centre on the 2013 General Elections, and the British Institute in Eastern Africa.

This panel will be chaired by Dr Samantha Balaton - Chrimes, Lecturer in International Studies at Deakin University. Sam obtained her PhD from Monash University in 2012, for research on grassroots politics, citizenship and ethnic identities in Kenya. Her current research is on democracy, citizenship, minorities and land rights in Kenya, India, and Indonesia.

The African Leadership Development Program was developed in Victoria to encourage leadership within the African community in Australia, and to enhance the skills of existing and potential leaders as they work within their local African community organisations. This successful program has been delivered over the last four consecutive years. Governance of the program is supported by a multi - sectoral Steering Committee with representation from the Victorian Government Office of Multicultural Affairs and Citizenship (OMAC), the Department of Immigration and Citizenship (DIAC), Leadership Victoria, AMES and the African Community Leaders.

In 2010 the first program attracted 33 African Australians of which 27 successfully completed the program. An evaluation of the program was undertaken by an independent consultant, with recommendations from the evaluation incorporated into a restructured Program from 2012. Dynamic interactive discussions about leadership in African Australian communities have been enriched by highly respected keynote speakers.

## BHLT Chair: TBA Photography Workshop with ThomasMukoya

Join veteran photographer Thomas Mukoya in a 2 hour practical workshop that will focus on the way we imagine and reflect Africa in its diversity. Thomas who has traveled throughout Africa shooting for MSF, UNICEF and UNHCR will give a brief introduction of digital photography. He will also show samples of his photographs, and the group will analyse participants' photos. Participants are encouraged to bring samples of their images.

The workshop will explore how to improve ones photographic skills in the field, as well as tips for capturing memorable images that can be used in reports, publicity and exhibitions. Thomas will discuss different types of cameras and how to choose the right camera for the job at hand. Lens preferences, the theory behind exposure and aperture settings, the care of cameras when traveling, and record keeping will also be discussed.
